1. All traders and stallholders must comply with directions of the club officers.
2. **Abusive Behaviour**- whether verbal, physical or written – will not be tolerated under any circumstances. Any violation will result in immediate removal from the premises and event.
3. Safety on site is there for everyone. Failure to comply with the events regulations will lead to immediate removal from the event without recompense, any problems speak to section leader immediately or safety officer on site
4. All Charges payable ON APPLICATION - No passes will be sent unless payment in full is paid by ... NO EXCEPTIONS
5. **Stallholders and Exhibitors must be covered by public liability insurance for a minimum sum of £5,000,00 (5 million Pound GBP)**
6. A valid copy of insurance certificate, must be included with this form
7. All Rubbish must be removed from site.
8. **Dogs must be kept on a lead. Owners are required to clean up after their dog.**
9. It must be understood that there is limited parking, and your vehicle will have to be moved to the public carpark after unloading and setting up of your stall/ exhibit.
10. **OPEN FIRES ARE NOT PERMITTED** in accordance with the landowners' conditions.
11. All Exhibits, items for sale or articles remain on site are at the sole risk of the Exhibitor/ Trader/ Caterer, the organisers will not be responsible for any loss damage or injury to equipment/ persons whilst on the site.
