Terms and Conditions

1. Traders must comply with directions of the club officers.
2. Abusive behaviour – whether verbal, physical or written – will not be tolerated under any circumstances. Any violation will result in immediate removal from the premises and the event

3. Safety on site is there for everyone. Failure to comply with the events regulations will lead to immediate removal from the event without recompense, any problems speak to section leader immediately or Safety Officer on site.
4. All certificates of insurance be valid and supplied on application. You must maintain a Public and product liability policy for a minimum of 5 million GBP. And indemnify of event organisers (West Dorset Vintage Tractor & Stationary Engine Club Ltd) against all claims product liability, damages and expenses whatsoever in any way arising out of their presence. Traders are responsible for their own security, and safety of their own goods and equipment.
5. All Payment must be made in full of application. Pitch is not guaranteed until all paperwork and fees have been accepted by steward.
6. No Passes will be sent until; this form and payment is completed.
7. No Sub Letting of pitch is permitted.
8. **Dogs must be kept on a lead. Owners are required to clean up after their dogs.**
9. Trade Stands MUST NOT use any part the Showground outside the boundary of their pitch. Please ensure that you have booked enough space for your stall, vehicle and camping if required.
10. Trade Steward and/or committee reserves the right to shut down any stall at any time.
11. Traders must remain open until 4:30pm on the Sunday. Please do not attempt to move your vehicle until after the official closing time.
12. Stallholders are strictly prohibited to sell Dangerous Weapons – The promotion and/or sale of offensive weapons such as knives, Laser Pens, catapults and BB guns or any form of firearms. Any Trade Stand found displaying, promoting or selling such items will be removed from the Showground immediately.
13. Temporary Events Notice – Exhibitors given permission to sell alcohol must apply for a Temporary Event Notice (TEN) from Dorset Council. A copy of the TEN must be displayed on the stand
14. **Open fires are not permitted in accordance with landowners' conditions.**
15. All exhibits, items for sale or articles remain on site are at the sole risk of the exhibitor/ Trader/ Caterer, the organisers will not be responsible for any loss damage, or injury to equipment/ persons whilst on site
16. Traders must remove all rubbish from site and keep their area tidy.
17. Refunds are at the discretion of Trader Steward only.

STALLHOLDERS ARE REMINDED THAT ENTRY TO THE SITE IS PROHIBITED PRIOR TO 10AM ON THURSDAY THE 11TH JUNE 2025, 9AM FRIDAY 12TH AND THE SITE MUST BE VACATED BY 12 NOON ON MONDAY 15TH JUNE 2026.
